Personal data that we process

This data is only accessible to a limited number of people due to necessary information that should be provided for your vehicle(s). The data collected for the vehicle and/or the owner are stored in separate databases, for added security.

Special and/or sensitive personal data that we process

Our website and/or service department will not collect data from our website visitors who are younger than 16 years, unless they have permission from their parents or guardians. However, we cannot check if a visitor is older than 16. So, we strongly encourage parents to be involved in the online activities of their children, in order to prevent, data about their children, to be collected, without the parental consent. For what purpose and on what basis we process personal data

How long we store personal data
